To create awareness among the students on the importance of “Ragging free Campus” And also make them aware of the human rights issues involved in it. To keep continuous watch vigilance over ragging issues so as to prevent its occurrence and recurrence. Auxilium College for Women and its residence facilities have zero tolerance for ragging and try to maintain a ragging -free campus. Students are directed to follow the rules and regulations abide by the institutions.

As a part of Anti -ragging cell, we organized an orientation programme for all UG and PG students on 5th July 2020 at 2 in the Media Hall.

The programme started with prayer song, and welcome address by Asst. Prof. D. Dayana Roselin, Department of mathematics. Rev. Sr. Dr. M. A. Maria Pushpam [Secretary, Auxilium women’s College Regunathapuram] and Rev. Sr. Dr. P. Selvarani [Principal, Auxilium College of arts & Science for women] inaugurated the anti-ragging cell and delivered anti ragging oath to students. An Orientation session on “ragging free campus” was taken by Asst. Professor S.Padmavathi, Department of Computer Science. During this session, she points out of objectives, necessity, and need for the formation of anti-ragging cell in each and every campus. She also explained the consequence and effects of ragging crime. ANTI-RAGGING CELL 2019 – 2020

Ragging is a crime and a criminal offence as declared by the Supreme Court of India. Auxilium Women's College has been successful in creating a ragging-free campus. We have an anti-ragging cell which comprises of the Principal and other staff members. The students are sensitized on the ill effects of ragging and the legal proceedings in curbing the practice. Awareness is created through orientation programmes in the first semester as well as before the commencement of each academic year.

Auxilium College for Women Regunathapuram and its residence facilities have zero tolerance for ragging and try to maintain a ragging-free campus. Students are directed to follow the rules and regulations abide by the institution.

An Anti-ragging awareness programme is conducted for the senior students by Sr.Dr.P.Selvarani [Principal, Auxilium College of arts &Science for women]. In her talk she explained the anti-ragging programme aimed at making students aware

laws of the country with respect to ragging and how it affects the lives of people victimized by it. She responded to queries from students with respect to anti-ragging and the talk concluded with a call to “Say no to ragging”.

An anti- ragging committee is constituted to ensure complaints with the provisions of the regulations as well as the provisions of any law for time being in force concerning ragging.

Students are encouraged to report any ragging act witnessed or experienced by them to the ragging committee or squad/students’ grievance redressal committee/any staff member with whom the student may feel comfortable.



ANTI RAGGING CELL 2018-19

The main objective of the cell is to create among the students on the importance of “Ragging free Campus” and also make them aware of human rights. Auxilium College for Women Regunathapuram and its residence facilities have zero tolerance for ragging and try to maintain a ragging-free campus. Students are directed to follow the rules and regulations abide by the institution. To avoid ragging in our campus the following measures are adopted.

Inside the campus an anti-ragging committee constituted to ensure compliance with the provisions of the regulations as well as the provisions of any law for the

time being in force concerning ragging. An Anti-Ragging Committee is constituted to prevent ragging and related activities in the campus. The committee is requested to make maximum awareness about the UGC Regulations on curbing the menace of Ragging in Higher Educational Institutions, 2009 and punishments.

Students and parents submit anti-ragging related affidavits to the institution at the time of admission then we are conducting awareness programme in our campus.

Anti-ragging committee conducted surprise visits to the classrooms to check the activities of ragging if any and prevent them regularly. Boards and hoardings were put up around the campus to exhort the students not to indulge in ragging.

Regular interaction and counseling with the students/class-representatives were done through mentors-mentee groups. Surprise inspections were done at the canteen, common rooms, toilets, bus stands, etc.

Students were asked to promote the anti-ragging campaign by participating in various events like slogan writing//poster making competitions.

Suggestion boxes were provided in the campus to drops student's complaints regarding harassment.



ANTI RAGGING CELL 2017-18

Anti- Ragging Cell should be one of the important part of Educational Institution 's mechanism. As per the guidelines of UGC under the act of 1956, which is modified as UGC regulations on curbing the menace of Ragging in higher Educational institutions,2009, established of “Anti- Ragging Cell” is very compulsory.

Anti- ragging Committee will be the supervisory and advisory committee in preserving a Culture of Ragging Free Environment in the Campus. The main objectives of this cell are as follows;

1. To aware the students of dehumanizing effect of ragging inherent in its perversity.
2. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
3. To promptly and stringently deal with the incidents of ragging brought to our notice.
4. To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments:

1. Debarring from appearing in any sessional test/University Examination.
2. Suspension from attending classes and academic privileges.
3. Withdrawing scholarships and other benefits.
4. Suspension from the college.
5. Cancellation of the admission.
6. Withholding the results.

Anti- Ragging committee is constituted to ensure compliance with the provisions of the regulations as well as the provisions of any law for the time being in force concerning ragging. It will also to nominate, monitor and oversee the performance of the Anti- Ragging squad in prevention of ragging in the institution.
