#### **Executive Summary**

Green Audit is defined as an official examination of the effects a college has on the environment. It helps to improve the existing practices with the aim of reducing the adverse effects of these on the environment concerned. Several institutions have applied various viewpoints to preserve the environment within the campus such as promotion of energy savings, re-cycling of waste, water use reduction, water harvesting etc, Green audit visualizes the documentation of all such activities taking stock of the infrastructure of the college, their academic and managerial policies and future plans. A green auditor will study an organization's environmental effects in a systematic and documented manner and will produce an environmental audit. A clean and healthy environment aids effective learning and provides a conducive learning environment.

A green audit can be a useful tool for a college of determines how and where they are using the most energy or water or natural resources; the college can then consider how to implement changes and make savings. It can also be used to determine the type and volume of waste, which can be used for a recycling project or to improve the waste minimization plan. 

#### Chapter 2.1

This requires data collection and efforts for clarification of environmental policies. Green auditing includes systematic identification, recording and analysis of components related to the sustainable development of an educational institution to preserve for future generations. The process has three important stages as a preaudit stage, audit stage and post-audit stage and a training programme conducted for students and staff to help them collect data during the audit processes. The pre-audit meeting was held in the college also provided an opportunity to reinforce the scope and objectives of the audit and discussions that were held on the practicals associated with the audit. This meeting was conducted successfully and necessary documents were collected directly from the college before the initiation of the audit processes. The actual planning of audit processes was discussed in the preaudit meeting. With the help of staff and the college management.

The college authorities were ready to encourage all green activities. It was decided to promote all activities that are environment friendly such as awareness programs on the environment, campus farming, planting more trees on the campus, etc. after the green auditing. The management of the college was willing to formulate policies based on green auditing report.

## 2.2 Scope and Goals of Green Auditing

Green Audit is the most efficient and ecological way to manage environmental problems. It is a kind of professional care that is the responsibility of each individual who is part of economic, financial, social and environmental processes. It is necessary to conduct a green audit on a college campus because students become aware of the green audit, its advantages to saving the planet and they become a good citizen of our country. Thus Green audit becomes necessary at the college level. A very simple indigenized system has been devised to monitor the environmental performance of this Auxilium College of Arts and Science College for Women. It comes with a series of questions to be answered on a regular basis.

This innovative scheme is user-friendly and totally voluntary. The aim of this is to help the institution to set environmental examples for the community, and educate the young learners.

Eco-campus concept mainly focuses on the efficient use of energy A and water minimizing waste generation or pollution and economic efficiency. All these indicators are assessed in process of "Green Auditing of the educational institute". Eco-campus focuses on the reduction of contribution to emissions, procures a cost-effective and secure supply of energy, encourages and enhances energy use conservation, promotes personal action, reduce the institute's energy and water consumption, reduce wastes to landfill, and integrate environmental considerations into all contracts and services considered to have significant environmental impacts. Target areas included in this green auditing are water, energy, waste, green campus and carbon footprint.




## **Auditing for Water Management**

Water auditing is a method of quantifying water flows and quality in simple or complex systems, with a view to reducing water usage and often saving money on otherwise unnecessary water use. Water is life; virtually everything we do or use each day involves water.

Yet, we do not give it the importance that is due to it. India will soon be a water-stressed country and we all need to work towards our water security. There is an increasing awareness around the globe of the centrality of water to our lives. This awareness crosses politics and around the globe of the centrality of water to our lives. This awareness crosses political and social boundaries. In many places, people have difficult access to drinking water. Often it is polluted. We need use water wisely to ensure that drinkable water is available for all, now and in the future. Water auditing is a mechanism for conserving water, which will grow in significance in the future as demand for water increases. It is conducted for the evaluation of facilities of raw water intake and determining the facilities for water treatment and recuse. The concerned auditor investigates the relevant method that can be adopted and implemented to balance the demand and supply of water. It is therefore essential that any environmentally responsible institution examine its water use practices.

#### **Auditing for Energy Management**

An energy audit is an inspection, survey and analysis of energy flow for energy conservation in a building, institution, process, or system to reduce the amount of energy input into the system without negatively affecting the output. It shows where the power consumption is more in the given system without negatively affecting the output. It shows where the power consumption is more in the given system. It can also be called controlling of the power usage to avoid losses and maximize efficiency. The energy management (audit) approach is understanding energy costs, benchmarking, energy performance, matching energy use to requirement, maximizing system efficiencies, optimizing the input energy; requirements, and fuel and energy substitution. Energy cannot be seen, but we know it is there because we can sense its effects in the forms of heat, light and power. This indicator addresses energy consumption, energy sources, energy monitoring, lighting, appliances, and vehicles. Energy use is clearly an important aspect of campus Attainability and thus requires no explanation for its inclusion in the assessment. An old incandescent bulb uses approximately 60W to 100W while an energy-efficient light-emitting diode (LED) uses only less than 10W. Energy auditing deals with the conservation and methods to reduce its consumption related to environmental degradation.





## **Auditing for Waste Management**

A waste audit is a methodically thought out process that can be used to determine the amount and types of waste that are generated by an organization. Information from these audit can help the organization to determine how we can reduce the amount of waste that an institution generates. In most workplaces, cardboard, paper, plastics, metals and food constitute the majority of what goes in the garbage. Pollution from waste is aesthetically unpleasant and result in a large amount of litter in communities which can cause health problems. Plastic bags and discarded ropes and strings can be very dangerous to birds and other animals. Solid waste can be divided into two categories: general waste and hazardous waste. General wastes include what i usually thrown away in homes and schools such as garbage, paper, tins and glass bottles. Hazardous waste is waste that is likely to be a threat to healthy or the environment like cleaning chemicals and petrol, unscientific landfills may contain harmful contaminants that leach into soi and water supplies, and produce greenhouse gases contributing to global climate change. The auditor diagnoses the prevailing waste disposal policies and suggests the best way to combat the problems.

## Kitchen waste of the College Canteen

- Water waste: There is no wastage of water in the college premises. RO system of wate purification is installed for clean drinking consumption and it is drained to the garder through the underground pipeline.
- Food Waste: Of about 400 persons daily in & through 'Dash' feed in which 5 to 6 Kg o kitchen and plate leftover waste is again fed to cattle through local persons on daily basis.
- E-waste, Chemical waste and Garden waste are disposed of with proper care.
- Biodiversity is biological and diversity. It refers to all the varieties of life that can b
  found on EARTH/Plants animals, fungi and microorganisms are part and parcel of it.
- Here in this college premises of 5 acres of green cover (3820.89\*5=19,104.45 Sq Mt) i
  maintained through the garden with different types of plants and shrubs, covering 95%
  with that of roof concrete area.



#### Auditing for Green Campus Management

Green Campus is an environment that improves energy efficiency, conserves resources and enhances environmental quality by educating for sustainability and creating healthy, living and learning environments. Green Campus rewards long-term commitment to continuous environmental improvement from the campus community. Green college makes a point to account for a sustainable living when designing and operating its buildings. Many of their facilities incorporate natural lighting, improve air quality, and reduce energy and water use. Trees play an important ecological role within the urban environment, as well as support improved public health and provide aesthetic benefits to cities. Planting trees without consideration for their specific location, and maintenance will not result in all of their wished-for benefits. It is essential to plan where the trees are planted and to plan their ongoing maintenance in order to maximize future benefits and to ensure long-term trees' survival and growth. Trees in a college yard improve air quality and can reduce temperatures with their cool shade. The area small environmental investment that will pay dividends for decades to come. In one year, a single mature tree will absorb up to 48 pounds of carbon dioxide from the atmosphere, and release it as oxygen. So while you are busy studying and working on earning those good grades, all the trees on campus are also working hard to make the air cleaner for us. Trees on our campus impact our mental health as well; studies have shown that trees greatly reduce stress, which a huge deal is considering that many students are under some amount of stress.

#### Auditing for Carbon Footprint

Microcosms of the world at large, college campuses are great test beds for environmenta change, and many students are working hard to get their administrations to take positive action The initiatives that are emerging are models for the larger society, and the students pushing fo them will be taking these lessons with them, too as they enter the workforce after graduation Foremost on the minds of green-leaning students today is a global warning, and many are joining hands to persuade their colleges to update policies and streamline operations so that their campuses can become part of the solution. Commutation of stakeholders has an impact on the environment through the emission of greenhouse gases into the atmosphere consequent to th burning of fossil fuels, such as petrol diesel. The most common greenhouse gases are carbon i dioxide, water vapor, methane, nitrous oxide, and ozone. Of all the greenhouse gases, carboi dioxide is the most prominent greenhouse gas, comprising 402 ppm of the Earth's atmosphere The release of carbon dioxide gas into the Earth's atmosphere through human activities i commonly known as carbon emissions. The question is what should be done to reduce carbon emissions. Often the challenge lies in choosing just the right approach that will o contribute mos to the objective. Naturally, the results of these interventions also have to be monitored and assessed:

Many colleges want to reduce their carbon dioxide (CO2) emissions. But that's not so easy given that a range of factors determine carbon emissions, including mobility, waste, and energy consumption, So, gaining insight into CO2 emissions is extremely important. An important aspect of doing an audit is to be able to measure your impact so that we can determine bette ways to manage the impact. In addition to the water, waste, energy and biodiversity audits we can also determine what our carbon footprint is, based on the quantity of carbon emission created. One aspect is to consider the distance and method traveled between home and college every day. It undertakes the measure of the bulk of carbon dioxide exhaled by the organization through which the carbon accounting is done. Towards sustainable development. It is necessar to know how much the organization is contributing.

## 2.5 Methodology of Green Auditing

The purpose of the audit was to ensure that the practices followed in the campus are in accordance with the Green Policy adopted by the institution. The criteria, methods and recommendations used in the audit were based on the identified risks. The methodology include preparation and filling up of this Auxilium College, a questionnaire, physical inspection of the campus, observation and review of the documents, interviewing responsible persons and data

analysis, measurement and recommendations. The methodology adopted for this audit was a three step process comprising of

Data Collection – In the data collection phase, exhaustive data collection as observation, survey was performed using different tools such as communicating with responsible persons an measurements. Data collection was done from primary sources.

Following steps were taken for data collection:

- The team visited each department, center, Library, canteen, gardens, campus etc.
- Data on the general information was collected by observation and interview,
- The power consumption of appliances was recorded by taking as average value in some cases.
- · Plants were identified using standard taxonomic books.
- · Waste generated was measured directly at the source of production.

Data analysis – Detailed analysis of data collected includes computation of energy consumption, analysis of latest electricity bill of the campus, understanding the tariff plan provided by the TN Power Solution the Energy supplying Company Tamil Nādu. Data related to water usage were also analyzed using appropriate methodology.

Recommendation – On the basis of the result of data analysis and observations, some steps fo reducing power and water consumption were recommended proper treatment methods for wast were also suggested. The above target areas particular to the college were evaluated through questionnaire.

## **Auditing for Water Management:**

Use of water in the college. With sources and flow transmission and lifting to overhead tanks with pumping motors. With the specification of motors used for pumping water. With storing capacity. Water wastages and prevention and stoppage. Rainwater harvesting and conservation of water. These are some of the criteria considered while auditing for water management.

## Rain water Harvesting:

The total roof area is 7968 Sq Mt.

The quantity of rainwater collected through the roof only and the same is harvested, ie 850\* 7968=6770250 Liters

[Here 850 is the average rainfall in Regunathapuram in mm 7968 Sq Mt is Roof Area]



#### **Auditing for Energy Management:**

List out the ways for use of energy in the college. Electricity, electric stove, microwave, LPG, firewood, Petrol, diesel and others. Are there any energy-saving methods employed in specify? Type of bulbs tube used for illumination etc. in a month. Are any alternative energy sources/nonconventional energy sources employed/installed in your college? Photovoltaic cells for solar energy, windmill, energy-efficient stoves, etc., How many CFL and LED bulbs have your college installed. Are considered for the auditing of energy management.

The college management installed the Solar Roof Top Photo Voltaic system power generation of capacity of 5 KW ANu synchronized with Everest Power Solution through net Metering system.

This enables the clean and green energy process. Additionally by implementing CFL, LED bulbs for illumination with BEEE Starred electrical appliances.

The reduction of CO2 emission with SRTPV System is an under........

0.932 354.36=330 Kgs of CO2 reduced from the emission, [0.932 kgs is the quantity of CO2 reduction in emission for 5 KWp of solar system installation].

Apart from this, the Carbon dioxide Emission can be reduced by taking necessary precautions and enough awareness is mentioned throughout the year among themselves between NSS, NCC, teaching, non-teaching, Canteen and the administrative staffs through the routine lifestyle and conversations very effectively and sufficiently.

#### Auditing for Waste Management:

The total strength of students, teachers and non-teaching staff in the College and their behavior is directly related to Waste management. The wastage may be E-waste, Hazardous waste (toxic), Solid waste, Dry leaves, Canteen Waste, Liquid waste, Glass, Unused equipment, Medical waste if any, Napkins, etc.. The quantity of the waste generated is calculated per day basis and a waste treatment system is necessary and is implemented. Composting, Recycling, Reusing, Others if any can be considered. Here the wormy compost is installed for the garden waste. Water waste is drained for gardening.



Auditing For Green Campus Management

Some of the following issues are to be considered...

- 1. The garden are in the college?
- 2. Do students spend time in the garden?
- 3. List the plants in the garden, with approx., numbers of each species.
- 4. Is there any plantations on your campus?
- 5. Use of any quantity of pesticides and fertilizers.
- 6. What are you doing with the compost generated?
- 7. Is there any botanical garden in your campus?
- 8. Is there any fruit-yielding plants in the garden or college premises?
- 9. What is the involvement of students in the green cover maintenance?
- 10. What is the total area of the campus under tree cover?

## Auditing for Carbon Footprint:

The total strength of students and teachers in the college with all categories ladies. / number of vehicles and bicycles were used by the staff and students.

Some of the issues for auditing if carbon footprint areas number of two-wheeler cars, common transportation, fuel consumption, the average distance traveled, number of visitor with vehicles, number of LPG cylinders used in the canteen, the transportation of vegetables and other materials to the canteen, and use of any other fossil fuels in the college etc are considered for the carbon footprint and carbon dioxide emission.

The burning of fossil fuels is the main source and cause of carbon dioxide release into the atmosphere. Carbon dioxide release for the stakeholders to reach the college is very high. It is contributing to global warming and increasing the pace of climate change.

## Follow Up Action and Plans

Green Audits are exercises that generate considerable quantities of valuable management information, The time and effort and cost involved in this exercise is often considerable and in order to be able to justify this expenditure, it is important to ensure that the findings and recommendations of the audit are considered at the correct level within the organization and that action plans and implementation programs result from the findings.

Audit follow-up is part of the wider process of continuous improvement. Without follow up, the audit becomes an isolated event that soon becomes forgotten in the pressures o organizational priorities and the passing of time.

#### **Environmental education**

The following environmental education program may be implemented in the college beforthe next green auditing:-

- Training programs in solid waste management, liquid waste management, setting up o
  medicinal plant nursery, water management, vegetable cultivation, paddy cultivation, tre
  planting, energy management, landscape management, pollution monitoring methods, and
  rainwater harvesting methods.
- Increase the number of display boards on environmental awareness such as save water save electricity, no wastage of food/water, no smoking, switch off light and fan after use plastic-free campus etc.
- · Activate the environmental clubs
- Set up a model rainwater harvesting system, rainwater pits, vegetable garden, roof garden etc. for providing proper training to the students. Conduct exhibition of recyclable waster products
- Implement a chemical treatment system for waste from the laboratories.

#### Awareness on carbon consumption

- Students and staff members may be made aware of the pollution caused by the use o
  vehicles.
- The carbon consumption awareness programs on carbon emission at the individual as wel as social level with help to avoid air and noise pollution on the campus due to vehicles.

#### Common Recommendations

- · Establish a purchasing policy towards environmental friendly materials
- Introduce UGC Environmental Science course to all students
- · Conduct more seminars and group discussions on environmental education
- Students and staff can be permitted to solve local environmental problems

- · Establish water, waste and energy management systems

Green audits form a part of an ongoing process. Innovative green initiatives have to b designed and implemented every year to make the college environmentally sustainable. Follow up programs of green auditing recommendations should be done meticulously before the nex audit.

In order to promote continuous improvement, it is recommended to conduct the nex green auditing during the year 2022.

#### Transparency of Green Audit Report

The green audit report is one of the useful means of demonstrating an organization' commitment to openness and transparency, then it should feel confident enough to make it green audit reports freely available to those who request them. As a basic rule, green audit reports should be made available to all.
